FROM RABBI KULWIN

The New Jewish Haven

The Gittlin Chapel was crammed with over 200 eager attendees recently to hear Atlantic journalist and frequent *Colbert Report* guest Jeffrey Goldberg speak about current events in the Middle East. Rabbi Dantowitz (a college friend of Goldberg's) and I and our spouses had dinner with Goldberg



before his appearance. He was charming, articulate, frighteningly knowledgeable and, unsurprisingly to any of his regular readers, incredibly funny.

His talk rambled through a number of Middle East concerns, including a nuclear Iran, an opportunistic Palestinian leadership, Arab states in turmoil, and an Israeli administration that, like administrations the world over, often seems more interested in campaigning than governance.

But one comment really caught my attention. He discussed the economic strides Israel has made and the relative prosperity many enjoy, though, as in the US, the have/have-not divide is going. Goldberg mentioned an Israeli family, friends of his, who had just decided to send their oldest child to college in the United States. Why? The parents perceived a chance that Israel could become a difficult and dangerous place to live, and they want to have a "toehold" in the US.

Wasn't Israel to be a haven for the world's Jews? One can understand these parents' concerns but the irony is still overwhelming.

Encore... Parashat HaShavuah with Rabbi Kleinman

Join us on **Saturday, June 4**, 9:00 AM when Rabbi Elliott Kleinman, Chief Program Officer of the Union for Reform Judaism, will once again lead us in Torah study. His topic will be "Lashon HaRa: Aspects of Civil Discourse."



In June 2009, Rabbi Elliott Kleinman, RJE, became the director of Advancing Reform Judaism for the Union for Reform Judaism (URJ). In this capacity Rabbi Kleinman is responsible for coordinating the Union's presence in the global and North American arenas. He is responsible for the Biennial Conventions of the Union, North America's largest Jewish gathering that brings together more than 5,000 synagogue volunteer leaders and professionals for 5 days of worship, music and study. Rabbi Kleinman is also the executive editor of *Reform Judaism* magazine.

Prior to taking on this responsibility, Rabbi Kleinman, was the chief program officer for the URJ. In that role he coordinated the work of the departments of Outreach and Synagogue Community, Jewish Family Concerns, Worship, Music and Religious Living and Social Action.

Rabbi Kleinman, RJE (Reform Jewish Educator), received his M.P.S.A from DePaul University, M.A.H.L. (Hebrew Union College - Jewish Institute of Religion), M.Ed. (Xavier University), and Rabbinical Ordination from the Hebrew Union College - Jewish Institute of Religion. Before coming to New York, Rabbi Kleinman was the Regional Director for the Northeast Lakes Council/Detroit Federation of the Union. Prior to his work at the Union for Reform Judaism, Rabbi Kleinman served as a rabbi at Temple Sholom of Chicago.

Four Questions: A Few Answers

When did you first ask the "arba kushiot" or "four questions" at the family Seder?



Can you recall how you stood with sweaty hands, and grape-juice stained tongue, to chant these ancient words? And if so, what melody did you use?

Reciting the words correctly before the entire mishpocha has been a rite of passage for young Jewish children for centuries. It was quite genius of the rabbinic creators of the Seder to encourage children's participation, because not only did it engage them in the ceremony, it fulfilled the mitzvah of teaching to our children the history of our people.

There are two melodies that are chanted in contemporary homes in America today. The first has come to be known as "the traditional" melody and the second is known as the "Israeli" melody.

The traditional melody is one which has passed down from medieval Rhineland Ashkenaz to cheders in Eastern Europe and then to the suburban synagogues in America.

It is based upon a "learning mode" or "lern-steiger" which was used to teach young boys the Talmud. Its sing-song up and down tone was very useful in helping students to memorize long tracts of Jewish texts, just as we have children memorize the ABC's through melody today. The text for the Four Questions comes directly from *Seder Moed, Mishnah Pesachim* 10:4. Once learned by students in the classroom, this same melody soon found its way into the home and became an integral part of the Seder ritual.

The second, "Israeli" melody was long thought to be composed by "anonymous" – meaning that no one could remember or care to find the composer. I am most grateful to Cantor Alane Katzew, whose research on this topic uncovered the composer, a little known Israeli composer named Ephraim Abileah (1881-1953). It was written in 1936 for his cantata "Chag Hacherut" (Festival of Freedom) which was performed only once in Haifa. Abileah was a devoted Zionist, and one of the founders of the Jewish Folk music Society of St. Petersburg. Interestingly enough, I had the chance to meet his grandson and granddaughter-in-law, as she was my voice teacher during my studies in Jerusalem.

Let Freedom Ring

As Passover approaches this year, the recent revolutions in countries around the world shed light on our understanding of freedom. While we think of our ancestors' journey from slavery to freedom, we bear witness today to the opportunity for more people to enjoy the blessings of this gift.



Jeffrey Goldberg, National Correspondent for *The Atlantic* and outstanding guest speaker at TBA on April 12, expressed that more freedom can bring more peace to our world. It is less likely for countries that embrace democracy to fight each other. This is an exciting and tumultuous time. While unclear what new governments may form in each country in turmoil, there is hope. But, this is tempered by the continued state of uncertainty of any peace process in Israel. What will push matters forward? Will it be a UN Resolution next September in favor of a Palestinian State?



The issues are complicated and much is beyond our control. But, we do have the freedom to express our thoughts and engage in learning. With freedom comes responsibility (so tradition teaches us as we move from Passover to Shavuot---from freedom/liberation to responsibility/10 Commandments at Sinai).

On a more personal level, we are taught *b'chol dor vador chayav adam lirot et atzmo k'ilu hu yatza mimitzrayim*, in every generation, each person is obligated to see himself as if he personally went forth from Egypt (literally: narrow places). In addition to reflecting on freedom globally during our Pesach Sederim, we can also reflect on what still enslaves us personally and what we can do to move toward freedom.

Temple B'nai Abraham Rallies Support for Reducing Deadly Mercury Emissions

Temple B'nai Abraham, as part of its leadership through the GreenFaith Certification Program, is rallying support for a new national rule aimed at reducing the emission of mercury and other toxins from power plants nationwide. "This rule will prevent thousands of people from serious illness and death—particularly those in poor communities near many power plants," said Rabbi Clifford Kulwin. "It's the right thing to do, and we are proud to support it."

On March 15, the U.S. Environmental Protection Agency proposed the rule, which is now open for public comment. The rule would require many power plants to install widely available, proven pollution control technologies to cut harmful emissions of mercury and other toxins. According to the EPA, the new rule will prevent as many as:

- 17,000 premature deaths and 11,000 heart attacks a year.
- 120,000 cases of childhood asthma symptoms and 11,000 fewer cases of acute bronchitis among children each year.
- 12,000 emergency room visits and hospital admissions, and 850,000 fewer days of work missed due to illness.

Signatures gathered by Temple B'nai Abraham will be added to over 1,000



additional signatures from faith-based sites gathered by GreenFaith, and delivered to the US EPA.

GreenFaith, the sponsoring organization of the Certification Program in which B'nai Abraham is participating, is an active advocate for environmental protection. Following the signing of the proposed rule, EPA Administrator Lisa Jackson met privately with GreenFaith's Executive Director, Rev. Fletcher Harper, and stressed the importance of support from people of faith. "This rule will save lives as soon as it is implemented," said Harper. Temple B'nai Abraham is offering important leadership by encouraging its members and community to voice their support."

Advocate for Reduced Mercury Emissions from Power Plants

On March 15, 2011, the U.S. Environmental Protection Agency proposed a new rule to reduce mercury and other toxic air pollution from coal-fired power plants – like the one above.

The proposal would require many power plants to install widely available, proven pollution control technologies to cut harmful emissions of mercury and other toxins.

The new rule will help:

- Prevent 17,000 premature deaths and 11,000 heart attacks a year.
- Prevent 120,000 cases of childhood asthma symptoms and about 11,000 fewer cases of acute bronchitis among children each year.
- Avert more than 12,000 emergency room visits and hospital admissions, and 850,000 fewer days of work missed due to illness.

But industry groups are attacking the proposal, hoping to weaken the rule.

EPA Administrator Lisa Jackson met privately with GreenFaith's Executive Director, Rev. Fletcher Harper, and personally asked GreenFaith to help rally support from people of faith. People like you.

Please, show your support for this life-saving rule, and help reduce mercury pollution from power plants.

Raymond J. Dowd, Esq. is leading the charge to recover Jewish property in landmark rights litigation in the federal courts.



Mr. Dowd is one of the nation's leading copyright, artwork and intellectual property litigators. Among other accomplishments, Mr. Dowd is the General Counsel for The Federal Bar Association, and the author of *The Copyright Litigation Handbook* (a leading treatise in the field). Recently, Mr. Dowd obtained an historic ruling from the United States Court of Appeals for the Second Circuit in favor of the artwork ownership rights of the heirs of a Jewish artwork owner whose property had been confiscated by the Nazis during the Holocaust and thereafter "acquired" by others.

Mr. Dowd will speak about the battles to recover art stolen from Jewish Holocaust victims, the undisclosed role of the Swiss in laundering looted art for the Nazis and the implications for US museums holding artworks of European origins.

He is a partner in a general practice Manhattan law firm, corporate, litigation, intellectual property (copyright and trademark), real estate, trusts and estates. Author, *Copyright Litigation Handbook* (West 3d Ed. 2008). Past President, Southern District of New York Chapter of the Federal Bar Association (2006-2008). Member Board of Directors, New York County Lawyers' Association (2003-2006). Former columnist, *New York Law Journal*.

Donors are encouraged to eat meals at usual times and drink plenty of fluids, preferably non-caffeinated, prior to donation. Long periods without eating may cause a reaction.
